## **TEQIP**

### **10.1.1 Confirmation of the minutes of the 9<sup>th</sup> meeting of the BOG.**

### **10.3.1 To approve the Action Plan for expenditure under ‘Centre of Excellence in Environmental Studies’.**

The action plan for expenditure was approved. However, it was suggested that the goal and objective be made more specific towards the CoE.

### **10.3.2 To approve the Action Plan for expenditure under ‘Centre of Excellence in Alternate Energy Studies’.**

The action plan for expenditure was approved. However, it was suggested that the goal and objective be made more specific towards the CoE.

### **10.3.3 To ratify the appointment of Senior Research Advisor, MIS Data Entry Operator and MIS Officer under TEQIP.**

The appointment of Dr.R.Krishnan, FNAsc., Senior Research Advisor, Tmt.G.P.Sangeetha, MIS Officer and Tmt.S.Akila, MIS Data Entry Operator was ratified.

### **10.3.4 To consider and approve payment to TEQIP assistantship to full time PhD scholars (Engineering and Non-Engineering) registered before Jan.2013 from the date of MoU signing.**

It was resolved to give assistantship to already registered PhD scholars using the following guideline.

1. Assistantship for all full time PhD scholars registered before Jan.2013 will be given from October 2013 for a period of 3 years from the date of registration or till the submission of Thesis whichever is earlier.
2. As a special case for the 2010 registered full time PhD candidates, assistantship will be extended for one more year (i.e. 4 years from the date of registration or date of Thesis submission whichever is earlier) provided the doctoral committee recommends.

**10.3.5 To discuss about Honorarium to be paid under TEQIP to Nodal Officers as per NPIU guidelines.**

**10.3.6 To discuss the action plan to achieve good governance.**

2. The accreditation process shall be expedited.
3. A format will be prepared by BOG to monitor Head of Institution performance.
4. The annual report of the institution shall be published (2012-13) on the website.
5. A statement of roles of BOG members shall be prepared.
6. Other aspect shall be reviewed from time to time.

### 10.3.7 To consider and approve the projects selected under SRF for funding.

Based on student presentation the following 2 projects out of 6 were approved for funding under TEQIP.

1. Automate Rig's ROD Pipe Welding Machine - Rs.3,44,689/-
2. Laptop tracking with GPS System - Rs.15,000/-

However the first project shall be reviewed for the total expenditure and the permitted expenditure be restricted to the optimum arrived figure by the Senior Research Advisor.

The expenditure shall be booked under TEQIP R&D.
