 - d. Taking up residence in the BO village and providing accommodation for the BO as per the provision of rules.
 - e. Furnishing of security for Rs.25, 000/- (Rupees Twenty Five thousand only) through Salem Postal Employee's Co-operative Society.
 - f. You have to produce an undertaking to the effect that you are having adequate means of livelihood and income from independent sources in writing.
 - g. You have to produce a declaration that you know cycling.
 - h. Declaration for not doing the Agency service in LIC, Pearless etc.
