- 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
- 4. In case of the program which has been granted accreditation for 3 years under Tier I January 2016 Document, Government College of Technology, Thadagam Road, Coimbatore-641 013, Tamil Nadu should submit the Compliance Report for the program at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to Government College of Technology, Thadagam Road, Coimbatore-641 013, Tamil Nadu as a whole.
