Retotalling is permissible for all current and arrear theory courses.

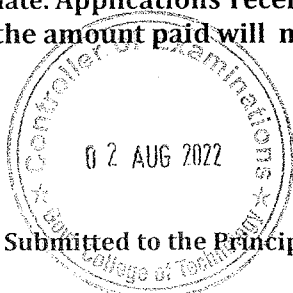
**ELIGIBILITY FOR REVALUATION FOR FAILED CANDIDATES.**
