INSTRUCTIONS TO CANDIDATES

DETAILS OF FEES:

REVALUATION FEE FOR FAILED CANDIDATES (UG): Rs. 600 per course

REVALUATION FEE FOR PASSED CANDIDATES (UG): Rs. 1500 per course

REVALUATION FEE FOR FAILED CANDIDATES (PG): Rs. 1000 per course

REVALUATION FEE FOR PASSED CANDIDATES (PG): Rs. 2000 per course

ELIGIBILITY FOR REVALUATION FOR FAILED CANDIDATES:

- 1. Revaluation for failed candidates is permissible for all **current** semester theory courses **ONLY**.
- 2. Revaluation for failed candidates in arrear courses is permissible for maximum of **TWO** arrear theory courses. (for current and Ex-final candidates)
- 3. Revaluation for failed candidates in arrear courses is permissible for any Number of theory courses. (for Extension candidates only)
- 1. Incomplete / Defective application will be rejected and the fee will neither be refunded nor adjusted towards any fee due to the Office of the Controller of Examinations, Government College of Technology, Coimbatore-13.
- 2. The candidate is advised to register for the course in which Revaluation is sought for within the stipulated time for the next end semester examination, without waiting for the supply of the results of Revaluation.
- 3. Applications received after the due date will be summarily rejected and the amount paid will not be refunded.
